Treasurers Report: Chief de Jong presented financial reports.

OLD BUSINESS:

REPORTS:

VOLUNTEERS: Firefighter Vosskuhler reported they staffed the youth Nordic ski event last weekend.

LOCAL: Craig Peterson is the new Local President due to Jordan Ockunzzi resigning to go to Boise Fire.

EMS: Deputy Chief Smith met with Sarah Curtin to talk about optional modules and advanced training. There was some work completed on our apparatus for an oil leak. The Departments new ESO reporting will be implemented in the next few weeks. This will integrate well with the County's CAD System to help streamline data and improve efficiency. Heather Norton has taken over the Departments medical reporting.

PREVENTIONS/INSPECTIONS: Chief de Jong stated that three fire districts are working with Valley County Planning and Zoning on the vacation rental ordinance. One of the items discussed is creating a Code Enforcement Officer position on the County level to enforce this. Chief de Jong stated that development wise Blackhawk phase five is on the docket at Valley County and he will be meeting with a developer this week to discuss this. There is also a new charter school on the docket in Valley County.

Training: Deputy Chief Smith reported that we have been developing competency-based training and evaluation for EMS, fire and special teams and a long-term training plan based on competency, proficiency, goals and certifications. He is working on task books for each rank to provide base level training to work for certain positions. Deputy Chief Smith also stated we have had three different vendors demo extrication tools. He is also working on developing a long term more defined plan to help get volunteers to drill times. Firefighter Garber has scheduled a wildland refresher for May.

APPARATUS/EQUIPMENT: Captain Class reported that the new pumper has a prebuild time frame around Easter. Deputy Chief Smith is implementing Crewsense for staffing and callback efficiencies and payroll efficiencies.

ADMINISTRATION: Jan stated that Jordan Zwygart will be here on March 30th to complete the audit. Chief de Jong stated we received the policy code update for annexation policies and a resolution was signed.

Monthly Report: Chief de Jong stated all quarterly meetings have been completed. Year to date calls are currently at a 17% reduction from the prior years. On February 11th Chief de Jong went to Boise to present a nomination for Firefighter Jon Metz and Firefighter Jason Beck for the Idaho Medal of Honor at the Attorney Generals Office. The nomination was awarded, and they will both be presented with the Idaho Medal of Honor Award on August 28th at the annual Idaho Fallen Firefighters Memorial.
